Evaluation Method for Bid RFP 24/17 will comprise of three (03) stages of evaluation: Stage One (1): Pre-qualification criteria (only bidders with a B-BBEE Status Level 1 Contributor are eligible to submit a bid and Administrative Compliance), Stage Two (2): Functionality. Functionality for points allocation will be evaluated and scored out of 100 points. Bidders should score a minimum of 70% (70 points) in order to be considered for further evaluation and Stage Three (3) will be price + B-BBEE (80/20).
